**Entry form required:** All participants must fill out & return entry form below. There is no charge for entries.

## Official Rules

1. All participants must complete an entry form.
2. All golf carts **must be pre-registered** by Monday, July 3, 2023.
3. Children under 7 years must be accompanied by an adult along the parade route.
4. Pets must be on secure leash held by owner at least 12 years old. No fighting, barking, excitable dogs. Dogs may be deemed unruly or suspicious of unruly behavior and may be excluded from the parade at the sole discretion of the parade officials.
5. **ABSOLUTELY NO GIVEAWAYS FROM PARADE ROUTE** Participants who throw candy, t-shirts, promotional items, etc. will be escorted out of line and subject to citation from Oxnard police. No exceptions. Non-adherence to this rule could end the parade.
6. All helmet, seat belt and licensing laws that apply to a moving vehicle apply in the parade. No alcoholic beverages are allowed. Non-adherence to this rule could end the parade.
7. All participants must be checked in by 10 a.m. NO confirmation will be mailed to you. **(Harbor Blvd. closes to thru traffic at 10 a.m.)**
8. No motorized vehicles will be permitted, except for golf carts and antique cars manufactured before 1967.
9. Any commercial entries must be pre-approved by the Ventura County Harbor Department.
